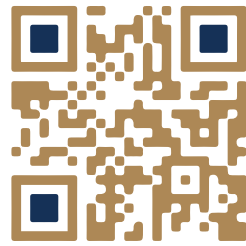

Indiana Personal Injury: Statute of Limitations Checklist

Understanding the statute of limitations is crucial for personal injury cases in Indiana. Use this checklist to keep track of important deadlines:

- General personal injury claims: 2 years from the date of the accident
 - This includes car accidents, slip and falls, and most other personal injury cases
- Medical malpractice: 2 years from the date of the alleged malpractice
 - Exception: If the injury isn't discovered immediately, you have 2 years from the date of discovery
- Product liability: 2 years from the date of injury
 - Note: There's also a statute of repose of 10 years from the delivery of the product
- Wrongful death: 2 years from the date of death
 - Not the date of the accident that led to death
- Claims against government entities:
 - Notice to state government: 270 days
 - Notice to city/county government: 180 days
 - File lawsuit: 2 years from date of incident
- Minors: Statute doesn't begin until the child turns 18
 - Parents can file on behalf of a child before they turn 18

Key dates to remember:

- Date of the accident/injury
- Date you discovered the injury (if not immediately apparent)
- Your 18th birthday (if you were a minor at the time of injury)
- 2 years minus one day from the incident: Last day to file in most cases

Remember, these are general guidelines. Specific circumstances may affect your case's deadline. Always consult with a qualified attorney as soon as possible after an injury to ensure your rights are protected.
